COMMITTEE LIAISON REPORTS

Recreation Center Advisory Committee

A verbal report was given on the August 26, 2021 Recreation Center Advisory Committee meeting. Discussion topics included new tennis program, current COVID guidelines, 2021 Capital Improvements and Purchases, Group Exercise Survey Results and annual facility maintenance projects.

Pool Advisory Committee

A verbal report was given on the September 9, 2021 Pool Advisory Committee meeting. Topics of discussion included Recap of 2021 Pool Season, Fee Recommendations for 2022 Season and an update on the Deerspring Splashpad project.

PTC Members' Council

A verbal report was given on the September 8, 2021 PTC Members' Council. There are currently over 530 active members as of September 1. The Center had 6 new members join in August, bringing the 2021 new member total to 41. A new member reception is being planned for October 6. The Members' Council continues their virtual meetings. Upcoming events include a trip to the Cubs/Brewers game in Milwaukee; the new Mumkinfest on September 25 in which mums, gourds and pumpkins will be sold; and the Healthy Lifestyle Expo on October 2.

NEW BUSINESS

Solar Power Presentation

Park District Director Nehila provided some background information. As has been previously discussed, staff has been looking at numerous options to incorporate solar power into our parks/facilities. We are continuing to explore the solar grid option of which we may have some additional information on that method. Another option we are exploring is the feasibility of partnering with a solar firm that owns panels and places them on rooftops in return for a reduced electric rate.

Terry Black of Realgy, LLC, presented information on solar power. Key notes include that Realgy pays all costs and expenses related to engineering design, permitting, construction, operation, maintenance and eventual removal of the panels. The terms Realgy are looking for is an 8-year commitment. As the length of commitment is longer than typical arrangements park districts enter into, we will need to explore the legal limitations and allowances permitted to the district. There are other park districts that have already implemented or going through the implementation of this type of agreement.

Staff will continue to research and will contact the roofing company regarding the roof warranty before requesting a proposal from Realgy.

Asphalt Paving Projects
