INVITATION TO BID

Sealed bids for purchase of **Turf Care Products** for the Deerfield Golf Club will be received by the Deerfield Park District at our office, 836 Jewett Park Drive, Deerfield, Illinois 60015. **Bids will be received until exactly 11:00 a.m. on Thursday, February 1, 2024 and then publicly opened and read.** Bids submitted after the closing time will be returned unopened. No oral or telephone proposals or modifications will be considered.

Proposals shall be submitted on the form of Proposal and returned to the Deerfield Park District office. Prospective Bidders may offer equivalent products to those specified by indicating on the bid proposal the product upon which their quotation is based and attaching technical data sheets describing the products offered. Each bid will be analyzed to determine the value of each item bid to meet its needs. All bids must include a notarized Bid Certification under Section 33E-11 of the criminal code of 1961, as amended, on the form provided by the Deerfield Park District. Failure to provide Bid Certification within 48 hours of the bid opening shall be cause for rejecting the bid. No bidder may withdraw their proposal after the hour set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding thirty (30) calendar days.

Delivery of products shall be made to the Deerfield Golf Club, 1201 Saunders Road, Riverwoods, IL 60015.

The Deerfield Park District and Board of Park Commissioners may reject any or all of the bids on any basis and without disclosure of a reason. The failure to make such a disclosure shall not result in accrual of any right, claim, or cause of action by any unsuccessful Bidder against the Deerfield Park District.
